

Summary of submissions

Generally, submissions supported the overall proposal. There were many positive comments which supported Council providing more availability for freedom camping, especially on reserve land. There were also submissions which encouraged Council to investigate opportunities to reduce restrictions on camping further; and submitters who raised concerns with the negative effects that freedom camping has on surrounding residential areas of identified restricted sites and sought more restriction on freedom camping.

Of the 74 submissions received, 26 submitters expressed general support for the proposal, specifically district wide rules and the areas proposed for restriction and prohibition. One submitter advised the district wide restrictions provide a good balance between encouraging visitors to stay in the area without paying for a campsite and protecting the environment.

27 submitters generally supported the implementation of the NZ Standard. One of these expressed they supported the Standard as it discourages inappropriate use of areas without facilities, including rubbish bins. Other submitters described the Standard as 'essential', 'brilliant' and an 'excellent idea'. However, 25 submitters expressed they were concerned with how Council intends to manage and enforce the new NZ Standard of self-containment rules. One of these suggested additional resource needs to be hired specifically to do this role. Currently, Council intends to enforce the bylaw on a complaints basis due to current staffing and resourcing levels. Signage and education are also effective forms of enforcement.

Ten submitters highlighted how significant Freedom Camping is to tourism and the economy, with differing views on how the Bylaw would either promote or restrict this economic benefit. Ten submitters requested Council reconsider providing areas for freedom camping in vehicles that are not self-contained. Three of these mentioned Hetana Street and/or Herries Park as options. During the development of the proposed Bylaw, Council investigated potential areas for freedom camping in vehicles that are not self-contained. Hetana Street Reserve, Herries Park and the area around the public toilets on Studholme Street in Morrinsville (near Countdown) were assessed, due to their proximity to 24-hour toilets. At that time Council determined none of these areas were appropriate.

Nine submitters requested Council provide more facilities including more toilets and rubbish bins. Two of these requested the existing rubbish bins be emptied more frequently. Six submitters emphasised the need to adequate signage and some suggested repainting of car parking areas to better show where Freedom Campers can park. Council is currently developing updated signage to accompany the new Bylaw, and have applied for further Ministry of Business, Innovation and Employement funding regarding signage, carpark painting and enforcement.

Four submitters suggested reducing the district-wide maximum number of nights a person can freedom camp in a particular location. The four-night maximum within the proposal is consistent with the approach already taken on reserves which provide for freedom camping as detailed in the General Policies Reserve Management Plan, and provides for enough time to camp over a long weekend. This maximum ensure short stays that will not adversely impact on any one location within the district and provides for turn over at highly sought after freedom camping areas.

Is this bylaw simply an over-reaction or bureaucracy for the sake of it. It is important to note that at the current time there are considerable legislative changes to Freedom Camping and what constitutes a self-contained vehicle occurring. This affects not only councils but all owners of any type of camping vehicle, effectively excluding thousands of NZ campers, including your residents from enjoying recreational camping on council managed land. As you know, camping in its various forms teaches basic skills, resilience and preparedness enabling campers to be better prepared and cope in an emergency situation. These skills don't develop in commercial campgrounds and are something that all district councils should be encouraging. Your council will have received advisory documentation on the new legislations and amended Freedom Camping Act from MBIE and Local Govt NZ. How will the council manage the new legislation? 				camp:	Council and merrily hand out \$400.00 fines to tourists who have only been here a couple of days? Bad news travels fast and your districts reputation to international tourists are at stake. The new legislation has affected national campervan hire businesses as well as domestic tourists and travellers. Where before 6 June 2023 a vehicle, including many older motorhomes with portable toilets could be certified as self-contained no longer can be. Travelling campers, who may have been travelling NZ responsibly for sometime or just arrived may have well fitted out vehicle with a portable toilet that is no longer considered self-contained under the Freedom Camping Act. Local residents with trailer campers or retro caravans with portable toilets can no longer be considered self-contained under the Act and subject to legislated/mandated \$400 fines for camping by a river or reserve unless the area is designated for non self-contained vehicles or all campers. It is important that your district council considers the implications of the legislation, whether you wish to remain a welcoming district for domestic and international tourists or a district to avoid? Establishing this bylaw is not a simple matter. For independent viewpoints check out www.campingthekiwiway.org Note: At the select committee hearings on the changes it was emphasised that there was an expectation that councils would continue to provide vehicle camping facilities, where facilities are available, for what are deemed non self-contained vehicles.
					Incorporation of New Zealand Standards The current self-containment standard, NZS5465:2001 is a valid four year standard which identifies vehicles have met a certain level of self-containment (no of persons for 3 days). However the Labour Government amended the Freedom Camping Act to 1) not recognise new certifications of vehicles with portable toilets as self-contained for 'free' camping council controlled land, even though these vehicles are self-contained under the standard. The council should also be considering the new Plumbers, Gasfitters and Drainlayers (Self-Contained Vehicles) Regulations 2023 which are in the transitional, implementation stage. We suggest Council reconsiders its position on whether non-self-contained vehicles can freedom camp at this site, particularly in light of the accessible toilets. Visitors in non-self-contained vehicles still contribute to the local economy and with a toilet nearby the occupants will unlikely create H&S concerns, particularly if they carry onboard portable toilets.

We encourage Council to reconsider its position not to allow non-self-contained campers at Herriers Memorial Park, for the reasons discussed above. A limited number of spaces set aside for non-self-contained vehicles should alleviate the concerns raised in the SOP. We appreciate why Council wants to prohibit freedom camping at their office carpark (35 Kenrick St) in Te Aroha, however given the proximity to enforcement officers and the size of the carpark it may be feasible and easier to manage to permit a small number of vehicles freedom camping on site from 7pm Friday to 7am Monday.
					Incorporation of New Zealand Standards The NZMCA agrees with the rationale, understanding the intention here is to ensure the bylaw remains consistent with the transitional provisions described under the Self-contained Motor Vehicles Legislation Act 2023. For consistency, and in light of the proposed amendments to RMP's, it might be prudent to align the definition of a 'certified self contained' vehicle under the General Policies RMP with the bylaw. The General Policies RMP only refers to NZS 5465:2001 and it is unclear whether the SOP anticipates this alignment. We imagine it might be difficult to enforce inconsistencies

					between the bylaw and RMP's, particularly if the RMP policies supersede the bylaw (refer sections 10 and 42 of the Freedom Camping Act 2011). Other feedback We commend the Council's thorough approach to assessing 'hot spot' sites and its endeavour to uphold the permissive premise of the Freedom Camping Act, while ensuring there are sufficient controls in place to manage the activity and protect the community from potential harm. We support the scope of the bylaw (as it refers to local authority areas) and generally support the site assessment tool (specifically the matters considered relevant under s 11 of the FCA). It's pleasing to see a genuine attempt has been made to justify prohibitions or restrictions, although we believe a score of 12 is a more appropriate threshold to consider outright prohibition. The new self-containment legislation alleviates many of the H&S concerns that would influence these site assessments. Section 1.2 of the bylaw should refer to sections 11 and 11A of the FCA if the intention is to keep Schedule 3 and possibly add to this list. Freedom camping is an important pastime for tens of thousands of NZMCA members and kiwi campers, many of whom will not be able to comply with the new self-contained laws from June 2025. These members (and non-members alike) are still responsible campers and should be accommodated at least in designated areas that can be monitored by enforcement officers.

Matamata Piako District Council is developing a Freedom Camping Bylaw in response to changes to the freedom camping legislation. This will include proposing specific sites in the district where freedom campers should camp and can't camp.

Do you have an opinion on freedom camping?

We're looking for feedback on a proposed Freedom Camping Bylaw.

Matamata-Piako is one of New Zealand's visitor hot spots. We've got lots of attractions to explore and host around 18,000 nights of freedom camping each year, but we currently don't have a Freedom Camping Bylaw to identify areas which are not suitable for those visitors to park.

New Zealand's freedom camping laws allow camping on all Council land and roads, unless the Council prohibits it through other methods (like a Bylaw or Reserve Management Plan (RMP)). So we're proposing to put a new Bylaw in place that strikes a balance between attracting and supporting tourism in our area, while protecting special places in our district.

This is your opportunity to have your say about the Freedom Camping Bylaw which proposes to:

- Restrict freedom camping to people in selfcontained motor vehicles (i.e. not tents or other temporary structures).
- Identify areas where people CAN'T freedom camp (prohibited areas).
- Identify areas where people MAY freedom camp (restricted areas), with a maximum number of selfcontained vehicles that can stay in each location.
- Set a maximum of four nights stay in any specific location within any one-month period.
- Prevent freedom camping within 500m of a place you have previously camped within the last month.
- Also, we would incorporate the NZ Self-containment Standard for Freedom Camping into the Bylaw.

In line with this, we are also proposing to make amendments to some of our Reserve Management Plans.

The following RMPs would be amended by adding the following statement to the Management Intent section of each RMP: "That freedom camping is permitted in self-contained vehicles in designated areas for a maximum of four consecutive nights."

- Hetana Street Reserve, Matamata (Passive RMP)
- · Waitoa Railway Reserve, Waitoa (Passive RMP)
- Herries Memorial Park, Te Aroha (Active RMP)
- Waihou Recreation Reserve, Waihou (Active RMP)

We also propose to remove Te Aroha Domain from Appendix E of the Active RMP, so it is no longer noted as a location which may be appropriate for camping.
