Rāpopotonga Matua | Executive Summary

The consultation process whereby the public is invited to make submissions has been undertaken on the Consultation Document for the draft Long Term Plan 2024-2034 (LTP) and several other documents.

Consultation was open from 21 March to 21 April 2024. 175 people submitted on the draft Long Term Plan and 33 submitted on the non-Long Term Plan related policies (Legal Highs, Smokefree Outdoor Spaces and Dangerous, Insanitary and Affected Buildings Policies). Further information is provided in this report on the topics submitted on and the themes identified.

At the time of writing this report Council has received two late submissions and these have been



included for consideration in the attached submissions. Eighteen submitters have chosen to present their submission to Council in person, a hearing schedule with accompanying submissions/grant applications in order of appearance will be circulated separately to this report.

Hearing process

The hearing of submissions is scheduled for 8 and 9 May 2024. Following hearing of submitters who have chosen to speak to their submission it is recommended that:

- 1. Council review all submissions received. It is suggested this could occur on Wednesday afternoon (8 May).
- 2. Council to provide direction to staff for further issues that require clarification resulting from the submissions or any further information that is required. Staff will report this information back to the meeting on 22 May 2024. At this meeting, Council will deliberate on the issues and make the final decisions on the LTP topics.

Given the number of submitters seeking to be heard and the likely timing for the meeting, Council may wish to adjourn the meeting to Thursday 9 May. On Thursday 9 May, the following matters could be considered:

- 3. Council make decisions on the Multi-Year Community Grant applications.
- 4. Council make decisions on the Fees and Charges (this is recommended to meet the timeframes for notification of any final fee increases to registered dog owners as part of planned communications).
- 5. If there are any further matters arising for staff to report back to the next meeting on 22 May 2024 this can be discussed.



Once Council has made decisions on the submissions, the Long Term Plan and other documents will be amended based on the decisions ready for adoption on 26 June 2024, where Council will also strike the 2024/25 rates. The Long Term Plan will also be subject to a final audit before Council's adoption.

7.3 Draft Fees and Charges 2024/25 - For Approval

CM No.: 2846091

Te Kaupapa | Purpose

The purpose of this report is to present an overview of the submissions received on the draft Fees and Charges and seek Council's decision on the matter.

Rāpopotonga Matua | Executive Summary

While most of Council's costs are recouped through rates, about 16% of costs are recouped through Fees and Charges. The proposed Fees and Charges were developed and aligned with the draft Revenue and Financing Policy, and propose that more of Council's revenue should come from user pays in order to keep rates down.

This has resulted in Council proposing to increase a range of fees across Council activities beyond the rate of inflation. This proposal has been consulted on with the community from 21 March to 21 April 2024 alongside the Long Term Plan (LTP) and the draft Revenue and Financing Policy.

Out of the 184 submissions received during the consultation period, 53 submissions were on the proposed Fees and Charges.

Of the 53 submissions, 19 agreed with the proposed option to adopt the proposed fees and charges, 26 did not agree with the proposal, four did not have an opinion. Four wish to speak to their submission at the Hearing on 8 May 2024. The submissions schedule with staff comments will be circulated separately to this report.

Council is asked to consider the submissions received and make decisions on the Fees and Charges (this is recommended to meet the timeframes for notification of any final fee increases to registered dog owners as part of planned communications).

During the consultation period, staff noted some typing errors or requested for minor changes to be made to the draft fees schedule. These changes are included in this report and are being presented to Council for approval.
