#### Rāpopotonga Matua | Executive Summary

Te Manawhenua Forum Mo Matamata-Piako Forum is a Standing Committee of Council and was first established in 2004. The relationship between Council and iwi/hapū continues to evolve as we move towards a post-settlement era.

The Forum operates under a Heads of Agreement first signed in 2004, with the latest review completed in 2023. The current Heads of Agreement is attached for members' information.

The purpose of this report is to seek direction from the Forum about whether a further review of the Agreement is required, and if so, how the Forum wishes to proceed.

#### Kōrerorero | Discussion:

- There was discussion regarding the potential renaming or providing greater purpose to the
  Heads of Agreement titled "Ki Tapu." A suggestion was made to change "Rahiri Tumutumu" to
  "Ngāti Tumutumu". However, it was confirmed that the current naming will remain unchanged
  until a formal request for change is submitted.
- Support was expressed for the adoption of the Heads of Agreement. However, it was noted
  that a work programme should be developed over the next triennium to allow for a thorough
  review. While a workshop has been held, it was considered insufficient time for full
  consideration. The work programme should ensure the Heads Of Agreement remains operable
  while enabling a comprehensive review.

### 7.6 Iwi-led grant

CM No.: 3119859

#### Te Kaupapa | Purpose

The purpose of this report is to seek a recommendation from Te Manawhenua Forum to access funds specifically for events such as Waitangi Day and / or Matariki.

#### Rāpopotonga Matua | Executive Summary

Staff are seeking a recommendation in regards to the allocation of funds to support culturally significant community events, specifically Waitangi Day and Matariki.

To enhance accessibility and ensure equitable distribution of resources, staff present two potential funding approaches for consideration:

#### Scheduled Funding Rounds

Establish dedicated funding rounds for Waitangi Day and Matariki in alternating years, with set application dates.

#### Year-Round Funding

Maintain a continuous funding application process, allocating funds on a first-in, first-served basis for organisations that have confirmed event plans.

#### Kōrerorero | Discussion:

- The forum discussed options for supporting iwi-led initiatives. One approach is for Council to allocate \$5,000 to support iwi-led events and programmes on significant dates such as Waitangi Day and Matariki, with this evolving into a formal grant process. It was suggested that Council delegate this funding to the forum, enabling flexibility within its work programme and the ability to shape the grant process. Direction to staff would be to develop a grant policy and bring it back to the forum at its first meeting in 2026. In the interim, the possibility of opening the grant based on suggested criteria was raised, acknowledging that further work is required.
- Questions were raised regarding the composition of the grant fund committee. It was noted
  that there is no official committee; the Grants Team conducts the initial review for eligibility,
  and decisions have been made by staff. The possibility of the Te Manawhenua Forum
  Tiamana sitting on the committee was discussed, but concerns were expressed about
  potential conflicts of interest if the Chair were to seek funding.
- Criteria for Matariki funding were considered, including whether funds could be used for
  activities beyond celebrations, such as purchasing plants for the rohe and involving children in
  planting across the district to mark the start of the planting year. Staff noted that these
  considerations would be addressed when developing the criteria within the grant policy
  wording.
- **Recommendation to Council:** The Forum requests Council delegation of allocated funds to support iwi-led events, programmes or initiatives related to Waitangi day or Matariki.

#### Te Kaupapa | Purpose

The purpose of this report is to summarise early engagement feedback on the review of Council's Policy on Dogs and Dog Control Bylaw, and to invite Te Manawhenua mō Matamata-Piako Forum to review and endorse the draft section of the Policy that acknowledges the cultural significance of kurī, reflecting previous feedback provided by the Forum.

#### Rāpopotonga Matua | Executive Summary

Council has recently carried out early engagement on dog control in the Matamata-Piako District to inform the review of its Policy on Dogs (Policy) and Dog Control Bylaw (Bylaw). This report summarises the engagement process and feedback received.

Te Manawhenua Forum mō Matamata-Piako (Forum) has contributed feedback throughout this process. Council seeks to reflect this feedback into documents and operational considerations and acknowledges the deep cultural connection between tangata whenua and kurī.

The Forum is invited to review and endorse the section on the historic significance of kurī to ensure accurate representation of mana whenua perspectives. The wording will be presented in the draft Policy to Council for approval to consult with the community in February 2026.

### 7.8 Plans, Policies, Bylaws and Strategy Update

CM No.: 3118943

#### Te Kaupapa | Purpose

The purpose of this report is to provide Te Manawhenua Forum with an update on Council's policy work programme for 2025/26 and seek feedback.

#### Rāpopotonga Matua | Executive Summary

The report outlines the topics scheduled for consultation from February to April 2026. Staff seek input from the Forum on key issues for consideration in the review of these documents, as well as suggestions for effective ways to engage with the local community.

#### Kōrerorero | Discussion:

- Concerns were raised about significant access issues at some marae, particularly Rangaiti on a major highway, and worsening conditions on SH29 due to increasing port traffic. These issues have been communicated to NZTA, and Mayor Ash noted that he raised them at the Regional Transport agenda yesterday and will raise them again at Thursday's meeting.
- There was discussion around Ngakaru o te Waka and future-proofing for mana whenua, with anyone from Te Manawhenua able to attend. The focus is on the Hamilton-Tauranga corridor, including the Cambridge-Piarere expressway and the Hinuera to Te Poi section. Concerns were raised about anticipated growth and increased traffic, highlighting the need to stay ahead of these issues. Raukawa is engaging with Waka Kotahi and stressed that action should not wait for a fatality, requesting MPDC's advocacy. Similar access and safety issues exist across other marae, and Te Manawhenua was encouraged to advocate for Raukawa in this space.
- The forum questioned whether NZTA has a manawhenua forum in the rohe, noting that such a forum exists in Auckland and asking why similar discussions on roading cannot occur locally. It was suggested that Te Manawhenua Forum request a meeting with NZTA's relationships manager to explore setting up a forum, potentially including iwi within Matamata-Piako.

The forum moved that they formally request NZTA to establish a manawhenua forum in Waikato, modelled on the Auckland approach. Mayor Ash Tanner to raise this matter at the Regional Transport meeting on Thursday.
