## 8.1 Te Manawhenua Forum Annual Survey

### Te Kaupapa | Purpose

The purpose of this report is to confirm the structure of Te Manawhenua Forum annual survey going forward.

### Rāpopotonga Matua | Executive Summary

Te Manawhenua Forum annual survey was developed by Forum members and is circulated each year for members to complete. One of the survey questions is required to remain the same, as it relates to the performance measure developed between Council and the Forum during the 2024-2034 Long Term Plan process.

The survey itself has been completed by the Forum since 2007, which provides historical data on the partnership journey between Mana Whenua and Council. For several years, the response rate from Forum members has been relatively low.

Confirmation of the structure of the survey moving forward is being sought from the Forum.

#### Ngāti Whānaunga -

Mātua Mike Baker giving thanks for the Mayor's attendance to the 35th year celebrations of the Ngā lwi FM.

#### Ngāti Rāhiri-Tumutumu:

Whae Hinerangi and Whaea Jill, native tree nursery - opening soon. This is intended to run a programme for the Alternative Education space for teenagers. with the aim of encouraging active student participation to earn NCEA credits.

#### Ngāti Pāoa:

Mātua Cr Gary Thompson provided an update Ngāti Werewere – leading a visioning exercise for the master planning of the KTM Marae development, which includes the church, clinic, kaumātua flats, and other facilities.

#### Raukawa:

Whaea Andrea – Introduced Mātua Cliff Kelly, Mātua Cliff then provided an overview of his PhD research project focused on the Waihou Catchment.

Mātua Leo Whaiapu - Reserve working with council, support of the Papakāinga.

#### Ngāti Maru:

Mātua Craig Solomon provided an update -

There has been strong engagement from iwi, with increased work in Tamaki due to a member retiring. They are involved in cleaning up the Kauaeranga and Kerikeri rivers, collaborating with Waikato Regional Council on monitoring, data sharing, and testing new innovations. The Waihou and Piako rivers are future focus areas for collaboration.

Socially, they have dedicated teams for specific roles, including overseeing three raupu groups and initiating the T Wrap group (Thames, Rangitahi Advisory Council). They've also provided opportunities for children to attend Community Board meetings to learn about decision-making processes. Additionally, they ensure the wellbeing of kaumātua through regular meetings and provide support to individuals dealing with challenges like court appearances, acknowledging the demanding nature of this work.
